**GIRLS SCHOOLS XI AIMS TO PUNCH ABOVE THEIR WEIGHT IN KWIBUKA T20s**  
**June 05, 2018:** Today is another **monumental flag-off** ceremony as **Uganda Cricket Association (UCA)** sends out another young, energetic and passionate **Uganda Girls Schools Combined Squad for the fifth edition of the Kwibuka Cricket for Peace Tournament in Kigali, Rwanda.**

But unlike other official send-off ceremonies, this one is **special in its own right**. Whereas the other **participating nations; Kenya, Zambia and Rwanda** will field their **senior women national teams**, **Uganda** have named a **student-packed side**. And the trip is not a just reward for hard work but it also serves as **motivation for the individual players** that **outshone their colleagues** at the **Girls Cricket Week Tournament** that was notched by **Jinja Senior Secondary School in May**.

**Lively all-rounder Rita Musamali** of Jinja Senior Secondary School will **captain UCA Girls Schools Select XI** for the **five-day** event that runs from **June 6<sup>th</sup> to 10 in Kigali** to mark the **24<sup>th</sup> anniversary of the 1994 Genocide against Tutsi** that claimed over **one million lives in 100 days**.

**Musamali** will have some **seniority** to bank on when the going gets tough with **fellow school and national teammates Immaculate Nakisuyi and Stephanie Nampiina** also named in **squad of 14**.

Both hard-hitting **Nakisuyi** and leg-spinner **Nampiina** boast of **big reputations** with the former having been named on the **ICC Women's Global Twenty20 Squad** that will play a handful of matches with **England County sides** whereas the latter is the reigning **Most Valuable Player (MVP) from last year's Kwibuka edition** that was scooped by **Kenya**.

The **Kenyans**, who powered their way to the title on their **debut outing in 2015**, will give **coach Habibu Mugalula** the **sternest test** and he will be hoping to catch them napping when the two **friendly foes** lock horns on the **opening day of action (June 7)** at the **beautiful Gahanga International Cricket Stadium**.

**Mugalula** will hope that the **pool of priceless talent** comprising of players from **Jinja SSS, where he tutors, Masaka Secondary School, Light Secondary School - Soroti, Ndejje Senior Secondary School, St John**

**Secondary School Mukono, St James Secondary School - Jinja and Mt. Rwenzori Girls Secondary School - Kasese** will have enough in their tanks to outlast the opposition.

Some of the players will also use this tour as their **last chance saloon** to convince selectors for berths on the **star-studded squad that will represent Uganda at the ICC Global Women's World T20 Qualifier** scheduled for **next month in Netherlands**.
